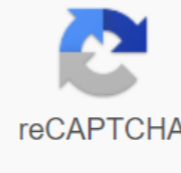

With this amendment, both bodies seemed to serve the same master. The 14th Amendment, which comes after the 13th Amendment, can use more traditional life, freedom, and wealth to describe the benefits of citizenship. The word life, freedom, and pursuit of happiness were used instead of in the Declaration of Independence. One theory is that if property rights were in the state's mission proclamation, it would have been impossible to put an end to slavery because enslaved African Americans were considered property. The original version of the right to own weapons was careful to make it clear that all Americans can maintain and possess weapons because they must serve in their national militias in the war era, but those Americans who possess weapons or have a religious prohibition for serving the government do not have to do so.
